In addition to payment, your volunteers will receive free entry to the Festival. A shift may end after 6 p.m. each day. Payment will not be issued if the group does not work a full eight-hour day.



AGREEMENT FOR NON-COMPENSATED SERVICES

PURPOSE

This agreement serves to delineate the responsibilities of the City of Lancaster in providing academic, work experience, and community service opportunities, and to create an understanding between the City and the individual regarding the conditions associated with this opportunity.

APPLICATION

This agreement shall apply to persons performing non-compensated internships for the purposes of satisfying academic requirements, or to gain practical work experience. Additionally, it shall apply to persons not affiliated with an academic program who volunteer services to the City in a non-compensated status.

AGREEMENT

It is understood between the City of Lancaster and _____ that the City shall provide **him/her** with the following work experience opportunity – activities include:

Volunteering for the 2017 California Poppy Festival™.

It is further understood that this agreement shall not in any way constitute nor create an employer-employee relationship between the City and _____. The City shall not be responsible or liable for, nor shall _____ be eligible to receive any compensation or benefits as a result of this agreement, including but not limited to, wages, or any other form of compensation, benefits, or unemployment insurance.

Term of Agreement

The period of service shall extend from _____ to _____. This agreement may be terminated upon the rendering of written or verbal notice by either party. Such termination will be effective immediately unless so stipulated by the initiator of the termination.

Release and Waiver

_____ (Volunteer) does hereby release and forever discharge and hold harmless the City of Lancaster (City) and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's activities with the City.

Volunteer understands that this Release discharges the City from any liability or claim that the Volunteer may have against the City with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities with the City, whether caused by the negligence of the City or its officers, or assigns.

Assumption of Risk

Volunteer understands that the activities carry with them certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. By signing this Agreement, Volunteer acknowledges that **he/she** has no physical or health limitation that prevents **him/her** from safely
